# 1 INTRODUCTION

- These terms and conditions govern your access to and use of the Services provided, owned and operated by Identitrade AB, a company registered with Bolagsverket in Sweden with registration number 556972-4288 (se chapter 18 for further details and contact information). Identitrade AB and its trading brand name Identiway are hereinafter referred to as "Identiway"/"we"/"us"/"our".
- 2. These terms and conditions form a legal agreement between you and Identiway regarding the Services. These terms and conditions follow the Identiway Trusted Service Practice Statement v 11. Using the Services indicates that you accept these terms and conditions. If you do not accept these terms and conditions, please do not use the Services and leave the online sites, mobile applications or other platforms from which they are provided.
- 3. We may revise these terms and conditions at any time by updating them, publishing them on our Website, in our app and notifying you by email at the email address you provided upon registration (if applicable) for the Services. You should check the Website

- 4. The TRA Service is a Trust Service operated under the Identiway Trusted Service Practice Statement v 11. The TRA Service is assessed for conformity with the policies set forth in eIDAS Regulation (EU) 910/2014, ETSI Standards 319 410, 319 411-1, 319 411-2, relevant ISO standards e.g. 27001, relevant elements of national German law in Verfügung gemäß § 11 Absatz 1 VDG (Mitteilung Nr. 208 des Amtsblatts-Nr. 11/2018 der Bundesnetzagentur) and relevant elements of regulation (EU) 2016/679 (EU GDPR).
- 5. The TRA Service uses Identitrade's authorization from the Swedish Financial Supervisory Authority to access bank account information on your behalf under Swedish legislation. See fi.se (https://www.fi.se/en/our-registers/company-register/details?id=171095).

# 2 DEFINITIONS

The following words and phrases have the following meanings in these terms and conditions:

- "Confidential Information" means information disclosed by (or on behalf of) one party to the other party in connection with these terms and conditions that is marked as confidential or, from its nature, content or the circumstances in which it is disclosed, might reasonably be supposed to be confidential. It does not include information that the recipient already knew, that becomes public through no fault of the recipient, that was independently developed by the recipient or that was lawfully given to the recipient by a third party.
- "Platform" means the online platform accessed by you after registration for the Services;
- "Services" means either the Identiway TRA Service that you access via a) a standalone web interface or as a part of b) a Trust service delivered through an app such as the Identiway App.

# 3 The Identiway TRA Service

1. The purpose of the Service is to assist online service providers seeking to identify you and entering into contractual relationships with you. These service providers need to

comply with anti-money laundering legislation, financing of terrorism and regulations on identification and esignatures. If you are using Identiway App, the TRA Service provides the registration functionality for Certificate Authority Services e.g. Identiway QeID Service (see identiway.com/repository for more information).

- 2. Identiway is a bank and agency independent solution supporting the identification of natural persons using a machine assisted manual process. All steps require your active participation and consent. The steps can be standalone or combined. The Service may require you to:
  - a. Access a third party online account in your name (e.g. a bank account) where you sign into the service electronically.
  - b. Share the data on the account with Identiway such that the Service can capture any data on the third party account necessary for your identification. In this instance the TRA Service may provide an additional interface between you and the interface of your third party online account service, designed specifically for the purposes of simplifying the process of verifying your identity.
  - c. Demonstrate that you are physically present in front of your smartphone using a smartphone video selfie service (liveliness check). Identiway will use this to establish that you are physically present and will also capture high resolution photos of your face to compare this with an ID Document photo.
  - d. Take a picture with your smartphone camera of a valid Government issued Identity document (e.g. Passport). Proceed to do a video capture with a smartphone of the Identity document. The Service may extract, process and verify any and **all** data on the ID document, including biometric pictures and signatures.
  - e. Enter into a live human to human video conference where you answer questions, demonstrate possession of the ID document and prove your registered address.
- 3. You as the User carry out and complete all necessary steps for proceeding with the Service such as signing in to the online banking or tax authority service, taking a picture with a smartphone camera of an Identity document and taking a selfie video. You have full control over all phases of the completion of an identification and can abort at any time. The service is based on your active participation and consent for each step.
- 4. In some instances, bank account access may include a micro transfer of funds (see below) provided by our licensed finance partners. Their logo will be present where this is the case and you actively need to request and perform the transfer. Partners part of the Service is provided by them with its own information and terms and conditions.
- 5. If the personal data that is necessary for identification is available on a second account (e.g. your tax account) accessible from the first account (e.g. your bank account)

through embedded functionality such as links, buttons, iframes etc, you grant us permission to activate the necessary functionality to process all personal data on the second account in order for us to extract and verify identity data.

#### LOGIN INFORMATION ETC PROVIDED BY THE USER

- Any identification executed with the use of personalised security credentials (codes/passwords etc.) shall be deemed to be carried out by the authorized owner of the account.
- 7. Any login information provided by you during the identity verification process will be collected and processed by Identiway. Identiway or its partners will forward the information, through the Service interface, to the corresponding interface of your online bank or tax authority through a secure connection. All communications made by you when using the Service are encrypted and the confidential login information of the User is forwarded to the corresponding input-field of the selected bank but is never stored. Identiway may, however, store and process any and all information provided by you in connection with using the Service.

#### PERSONAL DATA PROCESSING IN ON YOUR PERSONAL ACCOUNT

8. By using the Service, your agree that information about you available in various parts of a third party account interface (including for example name, address, telephone number, email address, sending bank account number, personal identity number and, where applicable, passport number/identity card number) is used by Identiway for the purpose of verifying the identity of the User.

#### MICRO PAYMENT OPTION

9. To demonstrate that you are in control of your account, we may also ask you to do a micro payment to our account, a so called "10 cent transfer". The purpose of the transfer is to comply with specific identification requirements found in many anti-money laundering regulations. This part of our service is provided by our licensed finance partners and the service is subject to their terms and conditions. You understand that by authorizing the transfer you will pay a micro payment from your account to us that will not be reimbursed. The amount will be transferred upon choice of account and accepting the transfer in the service.

10. We use automated software and manual vetting to process and read characters and words present on the photo of the Identity document, and/or process a selfie video and compare it with an ID document photo. Our Platform uses artificial intelligence to assess the authenticity of the named Identity documents. Finally, our Platform matches account statement data from your account with the identity data extracted from the Identity document.

#### MOBILE ID

11. In some the Identiway smartphone app or app SDK you are allowed to choose one or more PIN codes as part of the identification process described in Chapter 3. Upon entering on or more PIN codes and using it to sign your ID Document picture, you are issued an electronic certificate and signature that can be used for secure sign-in and esignatures. These services have separate Terms & Conditions (see identiway.com/repository Terms and Conditions Identiway QeID).

#### AUTHORIZATION/PERMISSION TO FORWARD INFORMATION ABOUT THE USER

- 12. Your information is forwarded on your instruction by Identiway to the Supplier for the purpose of the Supplier verifying the transaction and your identity, in order to prevent fraud, money laundering, terrorism or other criminal acts as well as to meet other legal requirements.
- 13. If you have used account access as part of the Service, the permission to forward data includes personal data processed by our trusted sub-contractors (e.g. Trustly) and delivered to us.
- 14. If you enroll in Identiway App, information can only be forwarded to a Supplier of your choice upon your active authentication (using PIN, TouchID or FaceID).

#### 4 FEES AND PAYMENT

You do not need to pay us for using the Services (other than the micropayment chapter 3, paragraph 7). We are paid by the third party that has provided you with access, and/or asked you to use our Services.

## 5 LICENCE GRANT AND USE OF CONTENT

In return for you agreeing to comply with these terms and conditions, Identiway grants you a non-exclusive licence to use the Platform on each device (e.g. phone, tablet) you use to access the Services. We only grant this licence to you and you cannot transfer or sell it to anyone else. We grant identical and similar licences to all users of our Platform. Where you are using an Identiway Service that has asked you to choose a PIN code you consent to and grant Identiway a license to install an advanced electronic signature service that can uniquely identify you, and host a service that allows you to use this signature when signing-in to secure services and e-signing documents.
- 5.
